Handlers will not be required to run in more than two consecutive braces. Registration information required. **Directions to Grounds:** Take Hwy. 29 south from Union Springs, AL. Travel approximately 8 miles. Turn right on South Gate Rd., just past Mile Marker 136. Look for Conecuh Station field trial sign. **Accommodations:** Master Rack Lodge—(334) 474-3600. Ask for field trial rates. Barn, lots, and camper set-ups available at field trial site with handlers and their owners having priority. Breakfast and lunch provided.
