The NGSPA No-Crossover rule will be enforced. Entry fees must be received before any dog competes.

Phone entries will not be accepted. Entries **MUST** be on an entry form and include ALL information.

Drawing for the National Amateur Shooting Dog Championship will take place at approximately 6:00 p.m., Friday, March 27, on the grounds.

Drawings for all other stakes will be held on the grounds no later than the night before the stake begins.

There is no training or roading allowed on the grounds for a two-week period before the trial begins.

This trial is run under the minimum requirements of the *FDSB* and NGSPA rules and regulations.

A current negative Coggins Test and Health Certificate for horses are required by Missouri law.
