Georgia Shooting Dog stakes will pre-draw, Friday, January 6, 2023 and start following the Quail Championship, but not before Tuesday, January 10, 2023. No vehicles allowed on courses.

Trials will be run on Di Lane Plantation, 4854 Herndon Road, Waynesboro, GA (property purchased by the U.S. Army Corps of Engineers, leased to the State of Georgia as public Wildlife Management land). Courses have been cleared to please any handler/owner. Birds will be released daily. Retrieval collars may be used. Six braces each day. No live ammunition. No dogs will be posted. Lunch will be served.
